The Parish Council has considered, approved and signed the Annual Governance Statement (Section 1) and the Accounting Statements (Section 2) on the same day but not provided a minute reference.

The Accounts and Audit Regulations 2015 stipulate that the Annual Governance Statement must be considered, approved and signed before the Accounting Statements at Section 2 by resolution of members of the Council meeting as a whole. In future, the Parish Council should ensure that the minute references clearly demonstrate that the Annual Governance Statement was considered, approved and signed before the Accounting Statements.

Section 2, Accounting statements, Box 9 Accounting for Fixed Assets

Box 9 of Section 2 of the Annual Return, the Accounting Statements, has been left blank.

The Council has confirmed that the figure should be £26,345. The Council should restate the 2016 figures as £26,345 on next year's Annual Return and write "restated" beneath the £ sign on the 2016 column.

A formal schedule of assets should be maintained and regularly updated. This should be reported in Box 9 of Section 2 of the Annual Return. The Practitioners' Guide has been updated in 2016 and new guidance on accounting for fixed assets will apply in 2016/17. The Council should review this guidance when completing the 2016/17 annual return and ensure that it classifies its assets appropriately and the correct value of the asset is included in Box 9.


